2. East Midlands Train Services at Radcliffe Station

Members were introduced to Jim Bamford and Jayne Wingad who can offer liaison and advice when negotiating services with East Midlands Trains.

The service at Radcliffe has dramatically dwindled over the last 30 years to the point of many residents not even being aware of the station!
