## 4. Matters Arising

## Item 4 Possible meeting with Landowers/Developers & PM's email and list of 11th June

It is recommended that the group arrange meetings with landowers/developers/agents and tenants to listen to their future plans and aspirations for the various sites identified for potential residential development. (SHLAA – Strategic Housing Land Availability Assessment).

Each will be sent a list of 5/6 questions and present answers to a small panel on a specified date within a specified time to enable a fair and equal process. These meetings need to be held prior to the publishing of the draft plan.

#### Item 4 Health Centre & Walkers Yard Car Parks – Update

Following on from the recent consultations regarding 3 hour restricted parking, the drop off parking bay at the Health Centre will be for a 10 minute period. Cllrs Georgia Moore and Jo Spencer (PC) will be undertaking an audit of local businesses to ascertain their parking needs, this information will then be forwarded to RBC, a decision will then be confirmed as to whether 28 spaces at the top of Walkers Yard car park remain unrestricted or some form of permit system be introduced, or possibly some other option.

Cllr Martin Culshaw proposed Cllr Roger Upton, seconded by Rod Brears. It was

Resolved: "That Cllr Upton be appointed as the Chairman of the Neighbourhood Plan Project Working Group."

# <u>Item 10 Land North of Nottingham Road Planning Application</u>

The application from Mosaic for outline planning to develop up to 300 houses was refused at the RBC Development Control Committee meeting on 28 May. The Parish Council sent a letter to committee members and officers urging them to delay/refuse the decision until the Greenbelt Review and the Neighbourhood Plan was completed. Cllr Georgia Moore thanked Cllr Upton for speaking at the meeting on behalf of the Parish Council and the village which influenced the right decision to refuse at this point.
