38. Neighbourhood Plan: Progress Report

Members received a Progress Report from the Chair of the Neighbourhood Plan Steering Group providing background information, details of the next steps to take and recommendations going forward following on from a recent Steering Group Committee meeting held with Phil Marshall of RBC. There was debate regarding whether to defer holding the referendum until clarification is known on the future adoption of the Community Infrastructure Levy as there are concerns that developers may put forward applications as soon as the Neighbourhood Plan is adopted but prior to any enforcement of C.I.L. However, it was noted that it is highly unlikely that the C.I.L will be considered by RBC until the same time as the revised Green Belt adoption in summer 2018. It was also noted that without the adoption of the Neighbourhood Plan the PC would not benefit from the C.I.L allocation scheme.
