1. Nomination papers may be obtained at **Civic Centre, Pavilion Road, West Bridgford, Nottingham, NG2 5FE** from the Returning Officer on Monday to Friday 9am to 5pm (excluding bank holidays), who will, at the request of an elector for any electoral area prepare a nomination paper for signature.
2. Nomination papers must be delivered to the Returning Officer, **Civic Centre, Pavilion Road, West Bridgford, Nottingham, NG2 5FE** on any day from the date of this notice, on Monday to Friday 9am to 5pm (excluding bank holidays) but no later than 4pm on Thursday, 9th April, 2015.
3. If any election is contested the poll will take place on Thursday, 7th May 2015.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Monday, 20th April 2015.
5. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Civic Centre, Pavilion Road, West Bridgford, Nottingham, NG2 5FE by 5pm on Tuesday, 21st April 2015.
6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Civic Centre, Pavilion Road, West Bridgford, Nottingham, NG2 5FE by 5pm on Tuesday, 28th April, 2015.
7. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Civic Centre, Pavilion Road, West Bridgford, Nottingham, NG2 5FE by 5pm on Thursday, 7th May 2015. The physical incapacity must have occurred after 5pm on Tuesday, 28th April 2015. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday, 28th April, 2015.
