# Clerk's Report on Previous Minutes

- 5. M.12 Four Year Plan Phasing and Priorities
  - a) Parking/Traffic/Pedestrian/Provision for Cyclists: Parish Clerk wrote to Clir Cutts asking that she attend an informal meeting to discuss these issues. Members expressed their disappointment with her reluctance to attend a meeting, however Clir Cutts has requested that some form of crossing is scheduled for Shelford Road. Clir Astill will see Clir Cutts face to face on Sunday 13th March to discuss these issues.
  - b) Conversion of Former Railway Mineral railway Line into a pedestrian and cycle route/Better Provision for cyclists in Radcliffe/Cycle Hire Hub > Holme Pierrepont Track/ Pedestrian Crossings/ Traffic calming measures: Cllr Bailey to draft letter to N.Q.C (cc. Cllr Cutts) and Highways England regarding the A52 missing cycle track, to send this week.
  - c) Investigate the possibility of providing a safe pedestrian access through the hedge between Royal Oak Car Park and Health Centre: Cllrs Thompson & Agar to find out the contract at Whitbread with a view to arrange a meeting to start discussions.

# 6. M. 15 Clean for the Queen Campaign / Litter Pick

On Saturday 5th March a large number of volunteers undertook a litter pick throughout the village. On the Sunday a dozen volunteers also litter picked around the Lily ponds area. A total of 70 volunteers over the weekend helped to tidy up the village. A big thank you from the PC for all their efforts and this will be published on the website.

# 7. M. 17 Severn Trent Water

Following the recent loss of water supply in Radcliffe, members were far from satisfied with the response from STW.RBC and N.C.C. Emergency plans were not invoked and some residents had to wait until 6,30pm before they had water. It was

agreed that a review of the Incident Management Plans need to be urgently addressed should the same emergency situation arise in the future. Adam Greest, Senior Technical Engineer at STW will attend the next Planning meeting.

# 8. Radcliffe Speed watch Team

An e-mail has been received from Stan Gregory confirming that the Radcliffe Speed watch Team plan to use the equipment for a small number of sessions to compare traffic speeds with those recorded at the same time last year. He thanked the Council for the safe storage of the equipment and will take up the offer. Stan also confirmed that the surveillance and recording of traffic speeds may only be carried out with supervision by the Police who would operate under the auspices of the Rushcliffe Community Safety Partnership, of which the PC is a partner.

  - Severn Trent Water: member of public not happy with lack of response from STW, meant that some residents
    including elderly relatives without water all day until the evening. Asked for contingency plans to be reviewed and
    wants recognition from the PC for Matt at the Manvers PH for the delivery of bottled water to residents on the day
  - Parking Issues: member of the public unhappy with the Orders made by RBC disagrees with the proposed Order for car parks in Radcliffe should be changed regardless of the signage offer, not legally binding.
  - Cyclists: member of public is of the opinion that NCC is unsympathetic to cyclists / lack of cycle paths in the village
  - Litter Pick: A resident may be able to provide photo images of Saturdays litter pick to upload onto PC website

The following items were considered:

- a) Lobby British Waterways to make safety Improvements at the Weir: PC agree too vague needs more detail
- b) Lobby Highways Agency to install pedestrian refuge in the centre of A52 near to Saxondale Kennels: High Priority letter to be sent to NCC / Highways Agency
- c) Lobby to improve and provide safer pathways, road crossings and cycle routes through the village ongoing
- d) Lobby to improve standards of pavement maintenance ongoing
- e) Encourage and possibly support a green energy group to get a hydro electric generator at the weir as and when
- f) Lobby the County Council to introduce a programme of converting the street lamps to LED programme started
- g) Lobby for clean pavements specific areas as and when
- h) Play our part in Campaign to Keep Radcliffe Tidy to co-inside with 'Best Kept Village'- ongoing
- i) Provide more litter and recycling bins- future Amenities meeting agenda item (with possibility of creating plan of where they are all located)

# 17. Rushcliffe Borough Council (Bingham, Keyworth and Radcliffe on Trent) Civil Enforcement Off-Street Parking Places Order 2016

RBC has advised that the Parking Places Order for the Health Centre and Walkers Yard Car Parks will come into effect on Monday 11th April 2016, the Orders state 3 hour limited parking no return within 2 hours 24/7, Monday to Sunday. Due to concerns raised from the PC during the consultation period, Peter Linfield Executive manager at RBC has advised that although the orders are 24/7 and Mon – Sun the signage displayed will state Monday to Friday 7am to 6pm and that the top section of Walkers Yard will become long stay. The PC has concerns that this arrangement can be changed at any time. The Clerk will contact Peter Linfield and Allen Graham Chief Executive to express Councils concerns regarding this issue and request that the process is started again.
