#### 2. Declaration of Interest

None received.

## 3. Chairman's Announcements

- The Chairman brought to the attention of members a Designated Public Place Notice prohibiting the
  consumption of alcohol. This one is erected at the bus stop on the Railway Bridge at Shelford Road. It was
  noted that some years ago the centre of the Village was a designated area. The scheme was introduced by
  the South Nottinghamshire Community Safety Partnership.
- Correspondence has been received from VIA seeking to relocate the bench next to the bus stop on Main Road outside the Grange. This item will be included on the next Amenities agenda.
- The Local Plan Part 2 Preferred Housing Sites Report shall be considered at the Rushcliffe Borough Council cabinet meeting on 12 September. The paper provides detailed information about the housing allocations across Rushcliffe and Radcliffe is now earmarked for 820 dwellings and information is now provided on suggested sites to be released from the Greenbelt. This means a potential 25% increase in population for Radcliffe and with East Bridgford and Newton also allocated additional houses this will put even greater pressure on Shelford Road. There will be further public consultation on the Local Plan in due course organised by RBC. The Neighbourhood Plan (which accepted up to 500) if adopted later this year will be in place prior to the adoption of the Local Plan Part 2 which is expected Autumn 2018.

The flyers promoting the Village Referendum on 19 October are being delivered to all households this week and next. The Clerk was asked to seek clarification from the delivery company on the Radcliffe/Cropwell Butler boundary at Upper Saxondale.

#### 6. Open Session for members of the public to raise relevant matters, limited to 15 minutes

Standing orders were suspended at 7.35pm

Cllr Upton will be presenting the Housing Sites Paper at Cabinet tomorrow evening. The Greenbelt review runs parallel with the Local Plan Part 2 and the Community Infrastructure Levy review. The Housing Allocation is driven by Government to address the shortfall in housing need and if the Borough does not have a plan in place then this could potentially lead to even more development. The Core Strategy states 13,150 more houses in Rushcliffe by 2028. Cllr Upton will continually campaign for a bridge or by pass to ease traffic congestion in the Village.

A resident is concerned about the Air Quality in the vicinity of the A52 and noted that it should be monitored. It is expected that this will take place once the road works are complete.

A resident was thanked for his persistence with Highways England in reinstating the left hand lane right turning at Nottingham Road junction. He, many other residents and the Parish Council must have had an impact in the influencing of the decision.

Cllr Thompson has also requested a meeting with David Young, Director of SCP Transport to continue campaigning for better services.

The Working Group has completed the consultation survey on behalf of the Parish Council which will be included on the next Agenda for approval.

- Cllr Moore attended the installation service for the new Vicar, Rev. Mark Tanner at St Mary's last Thursday. Thanks go to Cllr Moore for representing the Parish Council
- Cllr Agar advised that Trent Barton has a new fleet of modern buses with Wifi, USB and Air Conditioning.
- Cllr Agar will be handing out Neighbourhood Plan referendum flyers on Saturday in the Village, Cllr Culshaw would also help.
