PROPOSED PARKING RESTRICTIONS (CLUMBER DRIVE, QUEENS ROAD, RADCLIFFE ON TRENT) (TRO 8295) AND RELOCATION OF BUS STOP INCLUDING INTRODUCTION OF BUS STOP CLEARWAY.

CLUMBER DRIVE AND QUEENS ROAD, RADCLIFFE ON TRENT

PUBLIC ADVERT

Via East Midlands Ltd, is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire. To improve access for Trent Barton buses along Clumber Drive and Queens Road, Radcliffe on Trent, the County Council proposes to relocate bus stop RU0634 away from the restrictive bend on Queens Road, Radcliffe on Trent. To protect this, stop from obstruction by parked vehicles a bus stop clearway will also be introduced. The clearway will prohibit other vehicles from parking or waiting in the bus stop at all times and will be clearly identified with new road markings and signage.

The County Council also proposes to introduce 'No Waiting At Any Time' restrictions (Double Yellow Lines) on Clumber Drive and Queens Road, Radcliffe on Trent to ensure visibility and access for drivers and pedestrians is maintained. The proposals are shown on the attached drawing H/MN/3044/04.

Before proceeding further, I wish to consider the views of residents, businesses and organisations who may be interested in this matter. Any observations on these proposals should reach me in writing, either by letter or email, by **27th December 2019**. If your comments are in the form of an objection to the proposals, please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.

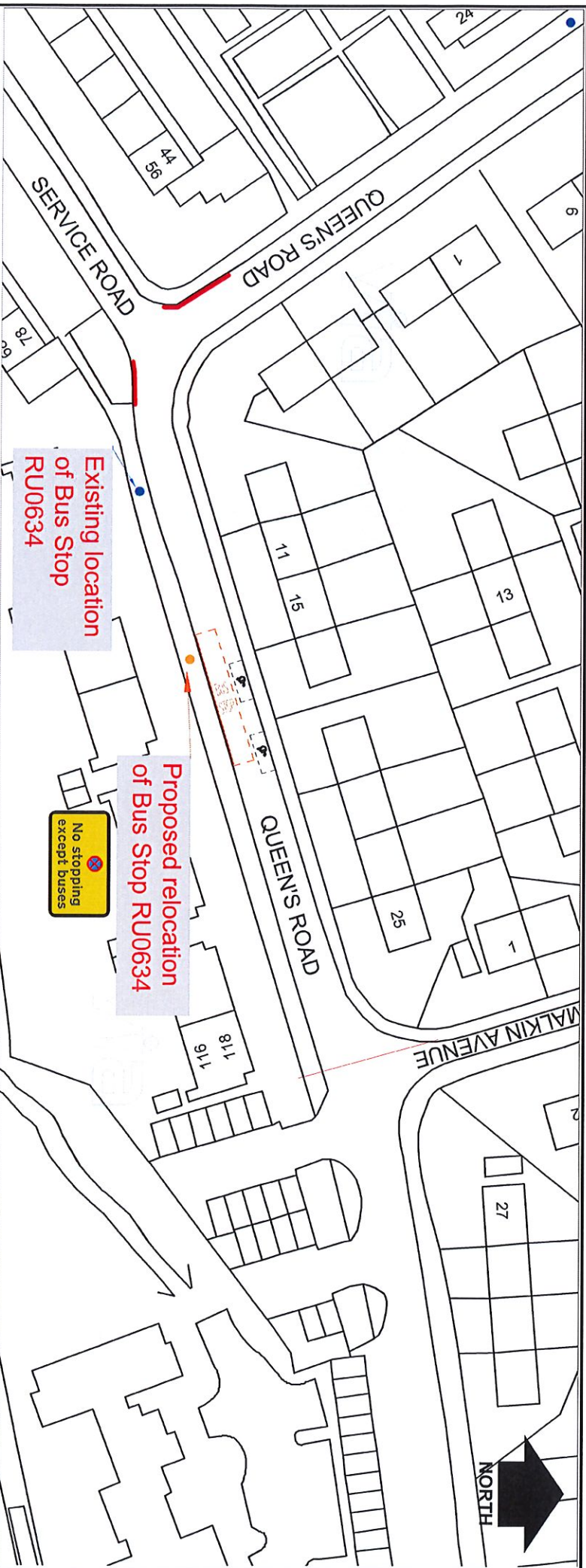

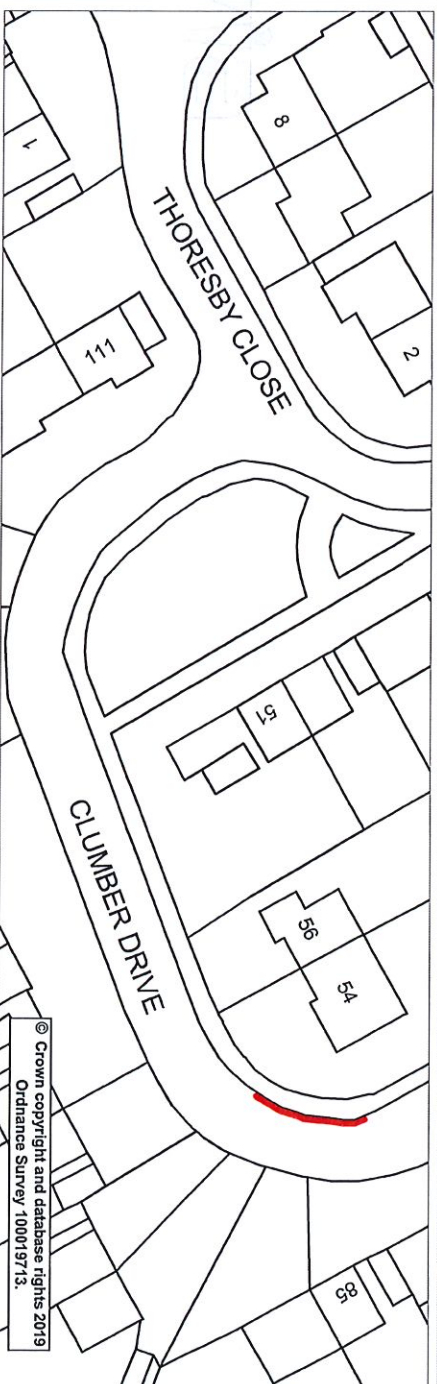

(Prohibition of Waiting) Traffic Regulation Order 2020 (8295)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads in Radcliffe on Trent the borough of Rushcliffe: -

1. Vehicles will be prohibited from **waiting at any time** along the following lengths of road: -

CLUMBER DRIVE, RADCLIFFE ON TRENT (north-west side)

- From a point 10 metres north-east of the property boundary of 54 Clumber Drive in a north-east direction for 15 metres.

QUEENS ROAD, RADCLIFFE ON TRENT (south and south-west side)

- From a point 7 metres south-east of its junction with Queens Road service road in a westerly and then a north-westerly direction for 26 metres.

2. Other restrictions – **Bus Stop Clearway** - No stopping, except buses, at any time.

CLUMBER DRIVE, RADCLIFFE ON TRENT

- **Bus Stop RU0634** – introduce 19-metre-long bus stop clearway from a point 41 metres east of Queens Road Service Road in an easterly direction for 19 metres
