Cllr Thomas would send the notes to members of the PC of the recent meeting held with Ruth Edwards MP the DfT, EMR and other Stakeholders regarding the Train Service. Significant improvements are expected to the timetable from May onwards. Discussions are ongoing.

Cllr Dunn reported that at the recent Parish Forum, Ruth Edwards MP was hoping to attend a future Parish Council meeting.

# 18 Reports from Borough and County Councillors

Cllr Upton reported that the next RBC Cabinet meeting is tomorrow night. Cllr Upton is submitting a report on urban spaces and new developments, (future maintenance and fees), if approved it will be used to seek new legislation on the management of new developments. Other items on the Agenda include the potential banning of loud fireworks in response to campaigners, the future and Masterplan of Edwalton Golf Course, and fusion power at the Ratcliffe Power station.

Cllr Upton also updated members on the new policy for enforcing planning conditions and powers to act on breaches.

Work is also being undertaken to seek a review of legal requirements on the duty to cooperate with adjoining councils, with specific interest in development allocations.

Referenced the RBC budget and Council tax – lowest in County and the new announcements of the East Midlands having Freeport status which will bring enormous investment into the region.
