Section 3 – External Auditor Report and Certificate 2021/22

In respect of **Radcliffe On Trent Parish Council - NT0140**

1 Respective responsibilities of the body and the auditor

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. 2 External auditor report 2021/22
