20. Parish Councillors and outside organisations reports

Cllr Bere notes that he has been made aware that there is an increased volume of anti-social behaviour issues on the new development sites which residents are concerned about. The Police are aware of this.

Cllr McLeod spoke about the initiative Warming Radcliffe and will be requesting a grant to pay for the use of a room at the Grange hall to provide a warm place and hot drink for residents of the village during the colder months. The village churches and the Royal Oak are a part of this scheme.

21. Reports from Borough and County Councillors

RBC Cllr Brennan informs that the local projects spending has been brought forward and asks if there are any schemes coming up and if so to make an application as soon as possible.

The ward notes that there are 50 current issues including a vandalised bus shelter on Shelford Road.

RBC Clir Clarke – the Remembrance parade has all been organised, the road closures have been published, they have a good number of volunteers with 120/130 participants in the parade. Note that there may be uncertainty for future years.

NCC Cllr Upton

COUNTYWIDE

1. The authority is progressing with the "Combined Derbyshire Nottinghamshire project", and there is a special County Council Full Council meeting on Friday 4th November to debate this and the proposed public consultation.

2. The STEP fusion energy project has been approved for the West Burton Power Station site near Retford.

3. County Hall is largely re-occupied after the fire, except for the Members' corridor where the fire started.

4. Discussions have started on the Council tax for next year.

LOCALLY.

1. The new "hot-box" road repair programme is almost complete in Radcliffe on Trent. Unfortunately Thomas Avenue has been taken out of this years programme due to difficulties with National Highways and access from the A52. I have asked if some of this money can be spent on a stretch of Orford Avenue between Vancouver Avenue and Vicarage Lane.

2. A new zebra crossing has been installed adjacent to Ashmoore's restaurant and the utilities have been marked out for two more raised platform zebra crossings on Shelford Road. One near Park Road and one near Queens Road. There will also be two lay-byes provided on the Queens Road junction to get parked cars off the grass verges.

3. Good progress is being made with the investigations on the flooding on Nottingham Road near to St Lawrence Boulevard. The next step is to excavate the culvert under the Nottingham Road.

4. The request for a 20mph speed limit to the New Road- Main Rd - Shelford Rd triangle has been halted, pending a countywide review into 20mph speed limits on suburban roads.

Cllr Dunn asks if there is any money left for shop fronts - no

Cllr McLeod asks if any more information on the health centre as it has been very quiet – it is currently in the hands of the partners and doctors.

Cllr Thomas asks if the review for the Villager bus service has started yet RBC Cllr Clarke states it has just started. Trent Barton who operate the service has an issue with the lack of drivers.
