3. Chairman's Announcement

The Chair informed the committee of the sad passing of Brian Hollis, who was a councillor at the Parish Council in the past and a recipient of the Civic Award in 2008. His funeral will be held on the 13th February, further details will be distributed.

PC Sanders came to the Grange to speak with councillors on Friday 20th January, informed them that there was low level crime in Radcliffe, with anti-social behavior and domestic issues making up the majority of issues.

There is a need to sort out how decisions are being passed onto staff. Cllr Dovey suggested a decision log being made. For now, an initial will be placed on the end of the minutes for those to action the decision made.

It was decided at Amenities meeting on 17th January to allow a memorial bench to be installed in Rockley Park, as this was a correspondence item and not an agenda item the decision now needs to be ratified.

18. Renewal and rental update re: 19 Rockley Avenue

The tenancy agreement for 19 Rockley Avenue is due to expire in April, it was agreed to instruct the Estate agent to offer the current tenant a further 12 month lease with a increase of £25 to £975 or if current tenant does not want to renew advertise with an increase of £75 to £1025. 19. Correspondence – email re mental health

Email received from Keith from Rehab Recovery, requesting an infographic on our website. Committee discussed and showed concerns with the content for legal and political reasons. Further investigation is required before the council can post to our website.

The Chair informed the committee that correspondence had been received from National Grid regarding a new electricity substation located behind 25 Trent View gardens and requested that a memorial bench be removed on Cliff path for a couple of days to allow them access. They have requested that the Council arrange the removal and return of the memorial bench and they will pay for it.

20. Parish Councillors and outside organisations reports

Cllr McLeod reports to the committee regarding Warming Spaces, numbers are still low but Craig Moray has seen a better turnout. She thanks Cllr James for help with putting this on to Facebook and pushing the message of a warm welcome.

Cllr Clegg attended a Police setting meeting recently which showed nothing new to report. It was noted that the Shelford Road new estate and Groom cottages, is classed as Princes Place estate. There is to be a crack down on Electric scooters.

Cllr James is to launch a ROTSA campaign for new volunteers.

Cllr Chambers updated the committee regarding the Hartwell Charity, they are now trustees and have full access to the bank account and money and will now decide on how it is operational.

Cllr Rhodes has arranged to meet with councillors to discuss IT and show the uses of Office 365 next Tuesday. The Chair suggest any proposals for this to be taken to F & GP.

21. Reports from Borough and County Councillors

RBC Cllr Neil Clarke informed the committee that the new Bingham Leisure centre will be opening on 20th February. Straggle Thorpe crematorium is nearing completion for opening in April.

Council tax has not been finalised yet however there may be a 2% increase subject to full council committee meeting.

Spitfire homes have been in touch and believes it will be a good idea to have a joint meeting with RBC and Parish Council with them as a standalone meeting to discuss the matter.

Regarding the history boards to be installed at the Radcliffe pub, could it be checked that it will not obstruct drivers view when they are trying to get out of the pub car park.

NCC & RBC Cllr Roger Upton informed the committee that the local plan consultation will be coming to an end.

The Combine Fire Authority may strike unless a deal is made in the next 10 days.

The proposed Shelford Road zebra crossing has gone to consultation. Notices have been put up on Hawthorne Walk to prevent dog fouling.

Missing tree on Water Lane, this will be replaced once the felled trees roots have had time to shrink.

The Parish Council will be contacted shortly regarding the UK Shared Prosperity Fund – Katherine Evans or Charlotte Gault regarding possible grants that may be required.
